**Regarding Sterilization failure case of Rajni w/o Raman Kumar :-**

- Claimant underwent LSCS with tubectomy on 09/01/2015 at GGSGH. She reported on 18/05/2020 with pregnancy, UPT positive on 18/05/2020. USG. On 18/05/2020 shows ectopic of 6 weeks 4 days at GGSGH and referred to DDU on same day. Patient was admitted for ectopic. Laparotomy done on 20/05/2020
- As per DQAC comments the cause for failure was inherent. As per OT notes of repeat surgery for ruptured ectopic on left side and on right side the two ligated segments of fallopian tube was very wide apart so much so could not be religated .  
The committe recommended the case for compensation under FPIS.

RCH Link Officer apprised the DQAC members regarding empanelment of doctors for family planning services. The empanelment done are as follows:

**AGENDA I :-**

**Regarding Sterilization failure case of Saraswati w/o Rakesh :-**

- Claimant underwent LSCS with tubectomy on 05/04/2016 at LHMC Hospital. She reported on 26/08/2020 with pregnancy, UPT positive on 26/08/2020. USG. on 24/08/2020 shows E.T.9.5mm, free fluid seen in cul-de-sac, tenderness present on probing. Patient was admitted in DDUH on 26/08/2020 and Laparotomy done on 26/08/2020 itself
- As per DQAC comments – As per records of initial surgery in LHMC, Delhi. OT notes and histopath. report reveals, patient underwent B/L Tubal ligation with LSCS by modified pomroy's technique. HPE reveals both tubes. In second surgery at DDUH per op. notes revealed right sided tubal ectopic pregnancy and on left side ligation was seen with stump being less than 1cm apart. Failure seems to be inherent to the procedure.

The committee recommended the case for compensation under FPIS.
